

## NEWICK PARISH COUNCIL

**MINUTES** of the Meeting of the Planning Committee of Newick Parish Council held at Newick Sports Pavilion, King George V Playing Field, Allington Road, Newick, on Tuesday 10<sup>th</sup> March 2020 at 7.00 p.m.

1. **Apologies for Absence** – Apologies had been received from Cllrs. Deacon, Hodge, and T Whitlock.

3. **Questions or Statements by Members of the Public** – Mr Cumberlege spoke briefly regarding Mitchelswood Inquiry, it was agreed that he may be asked to contribute during item 5.
4. **Planning Applications**

  - 4.2 **Tree Works Applications** - There were two tree works applications but neither had paperwork available. The Clerk has requested that this is uploaded by Lewes District Council.
5. **Update re Mitchelswood appeal** – It was confirmed that the Inquiry will be in Kings Church in April and the transport arrangements were discussed in depth. A suggested bus pick up route was agreed and that bus places would be booked by emailing the Clerk. It was agreed the Clerk would contact SSALC and ask if parking might be available at the SSALC building. It was agreed that a daily update during the Inquiry would be published.
6. **Update 45 Allington Road** – Cllr. Wickens advised that paperwork for this application is still not fully on LDC's website. It was agreed that Cllr. Wickens would draft a letter to L Palmer regarding the issue of documentation being available and this would be considered at the next full Council meeting.

Hodge has been reviewing the resource however only Mr Lucas had received the email and the Clerk subsequently forwarded this to the rest of the Council. It was agreed that Cllr.
