Spanish Chestnut (T17 of the Order) (T1 on the plan) – Crown reduce by 1.5m and balance. It was noted that the Parish Council's Tree Warden had supported this application.

It was noted that tree works application **TW/13/0067/TPO - 7 Growers End** had been refused by Lewes District Council.

- 5. Neighbourhood Plan – Progress Report from Steering Group –** Notes from Neighbourhood Plan Steering Group meetings held on 19th September and 3rd October 2013 had been distributed in advance. It was noted that the quarterly grant report required by the Department for Communities and Local Government had been completed. The Sustainability Scoping report had not yet been finalised as some of the questions needed to be reworded. Work had started on the draft policies and the Sustainability Assessments, it was reported that the latter was likely to be a time consuming task. Finally, it was noted that Cllr. Allen had agreed to act as publicity officer for the Neighbourhood Plan.
