Hazel Wood, Jackies Lane

Planning Application for Change of use of part of site from forestry to campsite for a maximum of 9 tepee/yurt style tents during April to September (resubmission of LW/11/1422). It was noted that approval had been given for this application subject to conditions detailed in the Notice of Planning Permission, and that the use would cease on or before 30th September 2015 and the land restored to its former condition.

6. Neighbourhood Plan – Progress Report from Steering Group – The Chairman reported on the Consultation Day which had been held on Saturday 8th June 2013. Approximately 300 members of the public had attended this event, which was considered to have been very successful. The Chairman thanked those who had helped on the day. It was noted that the final draft of the questionnaire would be submitted for approval at the Parish Council meeting on 25th June with planned delivery to households within the Parish in early July. It was agreed that boxes for collection of completed questionnaires should be made available in local shops, and door to door collections made by volunteer Councillors. It was noted that the documents approved at the Parish Council Meeting on 28th May had been made public at the Consultation Day and were now available on the village website.
